## ARE YOU GETTING THE MOST FROM YOUR REIMBURSABLE MEALS?

Today's foodservice professionals are challenged to maintain revenue streams that are being eroded by the loss of soft drink and snack sales and the reduction of a la carte menu items. In addition, personnel policies, labor costs, pressure on lunch room space, class schedules and limited time all contribute to the need to explore more efficient and effective methods of delivering important nutritional benefits to students.

The USDA's Food and Nutrition Service (FNS) recognizes that vending machines may play an expanding role in the operation of the National School Lunch and School Breakfast Program. FNS has guidance for school foodservice directors on how to use vending machines to provide reimbursable school meals. (See how to access this information at the end of this article.) The most important thing to keep in mind is that a vending machine used to serve reimbursable meals must be operated in compliance with program regulations.

Cashless vending machines may help schools with lunch programs and may help solve the problem of too many students to feed in too little time. Star Food is one of the leaders in developing reimbursable meal solutions that meets FNS guidelines to feed more students and at the same time increase school revenue. These cashless machines are also designed with a point-of-sale (POS) interface to match most existing POS systems.

In a program held at St. Petersburg High School in Florida, a Star Food cashless vending machine resulted in increased

- How does the machine comply with FNS guidelines, especially regarding properly dispensing a reimbursable meal and accurately documenting when a reimbursable has been selected by a student?

These cashless vending machines not only allow kids healthy, time-efficient choices for lunch, but also for breakfast and after-school snacks. They also provide schools an innovative reimbursable meal revenue generating solution.
